1. Welcome introductions and apologies for absence

Andrew Holt welcomed everyone to the meeting. Apologies for absence were received and accepted from Sam Hearth and Alex Mould.

4. Matters arising from previous minutes

There were no matters arising from the previous minutes.

5. Governance Professional

The meeting dates for the new academic year had been shared with trustees. Trustees were reminded to complete the Trustees' Survey and any outstanding equality, diversity and inclusion survey forms.

6. Continued Professional Development and Quality Assurance

Stuart Williams presented to trustees a new quality assurance framework for teachers which will feed into their performance reviews. During and following Covid, the schools within the Trust were in recovery mode, it is now important to drive things forward and focus on development.

One of the biggest issues facing schools is recruitment and retention of teachers, it is critical therefore to support staff whilst ensuring a healthy accountability. Previously, judgements of lesson observations, learning walks and subject reviews were mirrored to those of Ofsted - outstanding, good, requires improvement or inadequate.

In conjunction with senior leaders, team leaders and teaching staff a new framework was proposed that looked at how to upskill staff, bring on new people and give experienced staff more opportunities which builds on the work of Rosenshine's Principles. An Assistant Principal responsible for Continued Professional Development will put together a comprehensive training package for teaching staff, however, staff will also have choice and be able to take ownership of their individualised training. Judgements will now be moved into three categories: Effective, Exemplary or Support Required with the emphasis being on curriculum, pedagogy, relationships and attitudes and progress.

Question: Has the success of the new system been compared to the existing model? Stuart Williams confirmed that consultations have been made with heads of schools, team leaders and staff and teachers were encouraged that lesson observations will be moved away from the no notice system.

Overall, trustees were enthused by the new accountability framework which should make staff feel more valued.
