

DEED OF VARIATION TO THE SUPPLEMENTAL FUNDING AGREEMENT

THIS DEED is made the day of **13 Nov** ~~2023~~ **2023**

BETWEEN

- 1) The Secretary of State for Education of Sanctuary Buildings, Great Smith Street, London SW1P 3BT (the "**Secretary of State**"); and
- 2) **Rutland and District Schools' Federation** a charitable company incorporated in England and Wales with registered number 07552631 whose registered address is at Catmose College, Huntsman Drive, Oakham, Rutland, LE15 6RP (the "**Company**"),

together, referred to as the "**Parties**".

INTRODUCTION

- A. The Parties have entered into a supplementary funding agreement in respect of Catmose College on 1 May 2012 as amended and restated by a Deed of Variation dated 1 April 2016 which was further amended and restated by a Deed of Variation dated 24 August 2022 (the "**Existing Catmose College SFA**").
- B. The Parties now wish to vary and amend certain terms and conditions of the Existing Catmose College SFA in accordance with the terms of this Deed.
- C. This Deed is supplemental to the Existing Catmose College SFA.

1. INTERPRETATION

- 1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Existing Catmose College SFA.

2. VARIATION OF THE SUPPLEMENTAL FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the Existing Catmose College SFA shall be amended as follows:

The Summary Sheet shall be amended as follows:

- Clause 2B shall state the following:

- "2B The planned capacity of the Academy is 1,200 and the age range is 11-16 which for the avoidance of doubt includes pupils with designated places pursuant to clause 2.C. For the avoidance of doubt, notwithstanding that an individual applicant's age might be outside the specified age range of the

Academy, the Academy is not prevented from considering an application made by the child's Parent(s) in order to comply with the relevant paragraph of the Schools Admissions Code ('Admission of children outside their normal age group'), to request that the child be admitted to the school outside of the child's normal age group. Where such a request is agreed, the child should be educated in an existing year group. The Academy will be an all ability inclusive mixed sex school.

- 2.2 Except as varied by this Deed, the Existing Catmose College SFA shall remain in full force and effect.

3. Governing law and jurisdiction

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.

- 3.2 The Parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

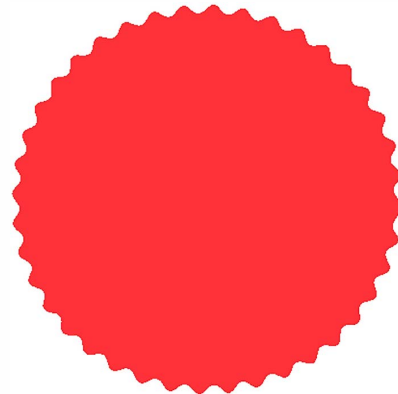
4. Counterparts
